**3rd INTERNATIONAL PHOTOGRAPHY SALON – 2019**

**SECTIONS OF SALON:**

There are four digital and 1 print sections of ANAPHAB 3rd International Photography Salon

- A – OPEN - (Color) PID
- B – PORTRAIT - (Color or B&W) PID
- C - NATURE – (Color or B&W) PID
- D – PHOTO TRAVEL – (Color or B&W) PID
- E – PRINT (OPEN) – (Color or B&W)

**PRINT SECTION:**

The printed photographs must be unmounted or mounted on a thin backing.

- Authors can send self-made prints with maximum size A3+ : 329 mm x 483 mm (13" x 19") (including mounting)
- Minimum size is 20cm x 30cm or 7,8" x 11.8".
- **JPEG Copies: During the on-line entry you will need to upload a JPEG copy of the prints.** (These copies are used when we produce the e-catalogue.)
- Accepted file types \*.jpg, \*.jpeg.
- Maximum image width (horizontal) is 1920 pix, Maximum image height (vertical) is 1080 pix.  
**File size maximum is 4 MB.**
- Images must not have any borders or signatures; images are exhibited on black/gray background.
- File name should be in English, unique, NOT containing special symbols. File name should be the artwork name. Example: sunrise.jpg. Words such as "Untitled" and "No Title" are not acceptable as part or all of an image's title, nor are camera capture filenames or titles consisting of only numbers.
- **NOTE:** The requirement for a JPEG copy applies to all prints including those produced in a darkroom.
- **Labels:** The image title (in one of the officially recognised FIAP languages and in the English alphabet), authors name, address, country, e-mail address and serial number as appears on the entry form must be included on the rear of the print.
- Pre-prepared detailed labels will be emailed to entrants for attaching to the rear of the prints. Prints must be received by the closing date for entries.
- **IMPORTANT: Prints submitted without the correct labels will be rejected and not shown to the judges.**

Please mark your packets – **No commercial Value – Photographs for Exhibition – DO NOT FOLD**

- Maximum weight of package is 2 kg.
- Please ensure that you have attached the special labels to the back of each of your prints.
- Authors that request their printed photographs returned an additional return fee of is mandatory. Prints will not be returned if return fee is not paid. The original packing will be used to return entries, and entrants must ensure that their packaging is adequate to be used for their return. If the packaging is not usable, we have no obligation of returning package to sender.
- When your prints arrive we will notify you by email.

## **ENTRY RULES:**

- Participation in the competition is open to all photography lovers, either amateur or professional. Members of the organizing committee, jury members and ANAPHAB representatives and their next of kin may not participate in the competition.
- In total, there are 5 categories in the competition. Entries are limited to not more than 4 images per section, category, or class. An entrant's four images will be distributed throughout four rounds of judging in that section.
- The participating photos must be in JPG format, 300 dpi resolutions, the maximum size in horizontal must 3840 pixels, in vertical size 2160 maximum 2MB file size. Therefore, attention should be paid to the resolution settings should be saved in JPG format with the highest quality recording option. The photographs that are not complying these rules will be eliminated.
- Each photograph must have a title.
- Contestants may use any traditional or modern photographic techniques.
- Photographs prepared for all categories should be upload to web site;

Except PRINT Category, no printed photos or those saved on a CD/DVD will be admitted for digital sections.

- **Please do not forget to write your name and surname, e-mail address, phone number and home address.**

In the event that photographs sent to the competition via internet encounter errors arising from the system or the user, please submit the error to [beninphotocontest@gmail.com](mailto:beninphotocontest@gmail.com), who will attempt to solve the issue as soon as possible.

·The competition results will be announced on the websites: **beninphotocontest.com** and additionally, all participants will be notified of the results by e-mail.

· The photographs that win awards in the competition and the other photographs presented as part of the exhibit will be broadcast on the website: **beninphotocontest.com**

Furthermore, the award-winning photographs, honorable mentions, and photos receiving special awards will be published Facebook, Instagram, Twitter.

· Participants assume all liability for all legal issue that may arise from works submitted to the competition.

·Every participant declares that the work belongs to him / her and that all permissions were obtained for the photograph he / she has sent. In the case that any of the winning participants acts in contradiction to this declaration, his / her award, title and all acquisitions he / she has achieved from the competition will be rescinded.

· Those who have submitted works have received the necessary permission on their own behalf, and declare that they accept full personal responsibility to undertake all disputes that may arise. ANAPHAB is not to be held responsible for any disputes that arise in this regard.

·Participants who are found to be in violation of the rules will be stripped of all awards, titles, or any other associated winnings. The award will be cancelled; the space will be left empty. This situation does not legitimize additional rights to the other participants. If the award has been granted, it must be returned.

· Prior to the jury's assessment, alongside the FIAP Red List will be utilized to identify participants of the competition who are to be eliminated.

·By the sole act of submitting his / her images or files to a salon under FIAP Patronage, the entrant accepts without exception and with no objection the following terms: that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP, that FIAP will use any means at its disposal for this undertaking, that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP, that in case of sanctions following the non-compliance with FIAP regulations, the name of the entrant will be released in any

form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations.

- ANAPHAB may request the original files of the winners of the photography competition, and other photos included in the exhibition.

- ANAPHAB accepts no liability for possible problems that may arise from the installation of the works.

- Photographs will be judged using ULTRA HD 4K 3840x2160 pixel resolution 55 inch TVs in a room than can be all dark.

#### **ENTRY FEE:**

- The entry fee is;

18 USD or 16 EUR for 1 and 2 sections

28 USD or 25 EUR for 3 - 4 sections,

12 USD or 10 EUR additional for PRINT Section

Entrants who wish their printed photos to be returned by post office must add 18 USD or 15 EUR for print section. Entrants may request photos to be returned together with those of other exhibitors, indicating in entry form the correct name and address of person that shall receive returned entries.

All participants must pay the entry fee.
